## CAT COUNTRY 951'S "LUISA GRAFF FEBRUARY FLARE" CONTEST OFFICIAL RULES

The Station will conduct the Cat Country 951's "The Cat Country Luisa Graff February Flare" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last ninety (90) days, and whose immediate family members or household members have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last ninety (90) day. Failure to respond to the initial verification contact within five (5) days of notification or failure to claim the prize within five (5) business days of verification as a winner will result in disqualification and forfeiture of the prize.
