CAT COUNTRY'S "CAT COUNTRY'S COOKIN' WITH MIRANDA" CONTEST OFFICIAL RULES

The Station will conduct the Cat Country's "Cat Country's Cookin' with Miranda" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility.
