CAT COUNTRY 951'S "LUISA GRAFF MOTHER'S DAY CONTEST OFFICIAL RULES

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Failure to respond to the initial verification contact within five (5) days of notification or failure to claim the prize within five (5) business days of verification as a winner will result in disqualification and forfeiture of the prize.
